The Deputy Educational Officer, Medak has caused inspection and submitted the report in the reference cited. The Govt. have accorded permission by opening of classes I to X (E.M) at a stretch from the academic year 2007-2008 vide G.O 5<sup>th</sup> cited.

After careful examination of the proposals received from the Society and also the inspection report of Inspecting Officer in the reference cited permission is hereby accorded to open classes VI to X (E.M.) during 2007-2008 in respect of The Jain International School, Kallakal Village, Mandal Toopran, Medak Dist. subject to the following conditions.

1. That the society shall be aide to the rules and regulations made in the Govt. orders 4<sup>th</sup> cited above.
2. That the Society shall provide the necessary amenities like accommodation sanitary facilities, drinking water facilities, furniture, Library, Laboratory, equipment play field required staff as per the staff pattern another facilities before approaching the competent authority.
3. That the Society shall apply for recognition immediately at the latest duly fulfilling the conditions.
4. That the permission is accords is restricted to this year only and it is not valid for the subsequent academic year.
5. That this permission does not confer any right on the society for claiming recognition.
6. That the permission is accorded to the Jain Madanraj Sony Charitable Trust and no other society of body can open a school on their behalf.
7. The permission is accorded to open to the school permission in the locality there shall not be a change in the premises of locality.
8. The society shall provide the necessary material even if it costs more that the deposit amount.
9. Proper and adequate parking area for vehicles shall be provided transporting the children to and for the school.
10. Proper and adequate sanitation facility shall be provided for students especially for girl students.
11. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
12. The school shall follow the traffic and safety guidelines indicated by the police and fire services departments.
13. The Parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
14. The school shall have first aid kit and the teachers shall be trained in first aid.
15. The permission shall be cancelled if any deviation noticed in future regarding fulfillment of all the conditions in G.O. cited.
16. The District Educational Officer, Medak at Sangareddy is requested to accord Permission to open classes I to V (E.M) as per the Govt. Memo 5<sup>th</sup> cited.
